Hennebont Ping Center - 1 rue Ousmane Sow - 56700 Hennebont - FRANCE

#### 6. **Eligibility and entries**

Players shall be under 23 years of age on the 31st of December immediately before the start of the year in which the Championships take place (players born on or after 01.01.2001).

**6.1.** Athletes from ETTU Member Associations with Belarusian or Russian passports, not representing any ETTU Member Association outside of Belarus and Russia, may enter as Individual Neutral Athletes (AIN). Conditions for AIN participation are as follows:

- AIN may be entered if they have submitted the ITTF Additional Terms of Participation document to the ITTF and have been granted acceptance by the ITTF.
- AIN may participate if the responsible authorities accept their entry into the hosting country.

#### Important note

There is a limited capacity at the venue and for the classifications to classify new players. To guarantee the participation of all Member associations, **ETTU will accept all preliminary entries with no restriction per association. Final entries will be confirmed after the deadline based on the available capacity and classification requirements.**

We recommend booking your trip only once you receive confirmation of your final entry to avoid inconvenience.

## 9. Hospitality

Hennebont Ping Center - 3 rue Ousmane Sow - Hennebont

Located at 100 meters from the Venue, walking distance (2 minutes).

Or

Tavern Ty Garn - 20 rue de la Gare - Hennebont

Located at 1 km from the Venue - shuttle service (3 minutes).

The accommodation price will be 150 € / day / person in a double room for both lodging options. This includes accommodation and food (3 meals per day).

## 10. Transport

Pick-up and drop-off will be organised on the official arrival (20 October) and departure day (27 October) at :

- Nantes Atlantique airport (NTE) (160 km from venue - 2 hours trip)  
and
- Lorient train station (10 km from venue - 15 minutes shuttle)  
Accessible from Paris Montparnasse in 3 hours ([www.sncf-connect.com](http://www.sncf-connect.com))

The transportation fee from Nantes Atlantique airport to Hennebont and back is 50 € per person.

The LOC will provide free shuttle from/to Lorient train station.

For the convenience of the participants, arrival by train to Lorient is recommended.
